The terms of reference of the Drafting Committee will be as follows :

- i) Review of IPR 2007 in terms of realization of objectives stated therein ;
- ii) new and emerging challenges in the current context of industrial development and policy responses thereof;
- iii) study of incentive packages.

- iv) identification of thrust sectors including automobiles and auto component and other manufacturing sectors, with tailor-made special packages to make the State an attractive invest destination ;
- v) comprehensive package for small and medium enterprises, including rehabilitation of viable sick units;
- vi) identification of linkages between SSI, medium and large industries with special emphasis on ancillary and downstream industries;
- vii) Special thrust on employment intensive sectors, including Information Technology Enabled Services, Handicrafts, Handlooms, Agro-industries, Fisheries, Poultry etc.;
- viii) special thrust on exports, including promotion of SEZs;
- ix) special emphasis on strengthening availability of technical manpower in required fields;
- x) Public Private Partnership (PPP) in promotion of industrial infrastructure;
- xi) investment promotion and facilitation mechanisms and measures;
- xii) industrial infrastructure matters including coal, power, water connectivity, port handling capacity etc.;
- xiii) Centrally Sponsored Plan Schemes, Central Plan Schemes and State Plan Schemes for industrial development;
- xiv) study and recommend a mechanism for creation of an Industry Development Fund;
- xv) any other issue

The Committee may co-opt experts and other members. The Committee may also interact with State, national and sector specific industry associations and councils, to obtain their views and suggestions on the policy and procedural matters. The Committee should submit its reports within 20 days from the date of notification.
