

No. 4432 /I., : In exercise of the powers conferred under sub-section(1) of Section-8 of the Orissa Industries (Facilitation) Act, 2004, Government have been pleased to designate Industrial Promotion & Investment Corporation Limited(IPICOL) as State Level Nodal Agency to carry out functions specified in the said Act & Rules made there under.

- (1) The State Level Nodal Agency will function as "SHILPA JYOTI" as envisaged in paragraph 5 of the Industrial Policy Resolution 2001.
- (2) As stipulated under section 8(1) of the Act, the District Industries Centers shall be the Nodal Agencies at the District Level which will function as "SHILPA SATHI" as envisaged in paragraph 5 of the Industrial Policy Resolution 2001.
- (3) Government have been pleased to decide that the theme for promotion of Orissa as an investment destination shall be "Opportunity Orissa".
