**RESOLUTION**


**Dated - 7<sup>th</sup> October, 2020**

**No. - IND-HI2-POL-0001-2020- 6400 /I.**, In order to reduce the regulatory burden and to provide Businesses an opportunity to give feedback on draft/ proposed business regulations, before they are enacted, the following provision shall be followed:

1. All new business regulations before they are enacted have to be reviewed by the concerned Department, based on the following criteria:
  - a. Legal basis: The new regulation or license shall be reviewed from the perspective of whether it has a basis in any defined / existing law / act / policy of the Government.
  - b. Necessity: The new regulation or license shall be checked to ensure that it will help Government achieve its objectives.
  - c. Business-friendly: The new regulation or license shall impose minimum burden on the businesses to achieve the Government's objectives.
2. The draft business regulation shall be published online under the URL: [www.investodisha.gov.in](http://www.investodisha.gov.in) for a minimum duration of 30 days to invite public comments/ feedback prior to enactment.
3. Comments / feedback received on the draft business regulation shall be published online under the URL: [www.investodisha.gov.in](http://www.investodisha.gov.in) along with details of how they were addressed in the final regulation.
4. Once the regulation has been implemented it shall be included in the Info-wizard module of GO-SWIFT online single window system within 30 days.

This resolution comes into force with immediate effect.






