RESOLUTION

PT1-IND-HI1-PRJS-0001-2018- 4840 /1., Bhubaneswar, Dated the 2/6/22

Sub: Proposal of IDCO to procure 871.427 Acres of land for its Land Bank from M/s Tata Power Co. Ltd. earlier leased out for Coal-based Thermal Power Plant at Barang Tahasil in Cuttack district.

It has been decided by the State Government that the 871.427 acres of land earlier allotted to M/s Tata Power Co. Ltd. (TPCL) under Barang Tahasil in Cuttack District for proposed Coal-based Thermal Power Plant shall be brought back into the Land Bank of IDCO. The said land shall be utilized for attracting new industrial and infrastructure projects, which will create huge employment opportunity for the people of Odisha. In order to bring back the said land into the Land Bank of IDCO the following decisions have been taken by the Government:-

1. IDCO to accept the proposal of TPCL to surrender the 871.427 acres of land into the Land Bank of IDCO by making a payment of Rs.101,62,80,822 to M/s TPCL. Out of the said amount of Rs.101,62,80,822, IDCO shall meet the expenditure towards refundable land cost of Rs.62,83,48,517/- from the funds available in the Land Bank Scheme.
2. IDCO to incur additional expenditure of Rs.27,99,21,176 towards ex-gratia and R & R benefits for the land-losers and incur this expenditure out of its own resources.
3. Any additional expenditure required for taking possession of land and to secure it by way of construction of a boundary wall etc. will also be incurred by IDCO out of its own resources.

Order : Ordered that the resolution be published in the extraordinary issue of the Odisha Gazette and copies of the Resolution be forwarded to all Departments and all Heads of Departments.
