Subject: Amendment of Industrial Policy Resolution 2022

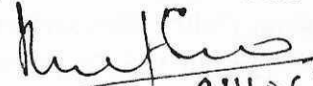

2	New sub-section 4.2(xiii)(e) under Section 4 Incentive Framework of IPR-2022 (Thrust Sector)	(Not Available)	Provision to be added: 4.2(xiii)(e) Non-mineral based new industrial units located in the districts of Bolangir, Boudh, Deogarh, Gajapati, Kalahandi, Kandhamal, Kendrapada, Koraput, Malkangiri, Mayurbhanj, Nabarangpur, Nayagarh, Nuapada, Rayagada and Subarnapur with a minimum investment of Rs. 5 crores in Plant & Machinery and providing direct employment to not less than 20 state domiciled people.
